NON-EXCLUSIVE MATERIALS LICENSE

INTRODUCTION AND PURPOSE: *{B/qKC}*: *Black/queer Kansas City* is a digital archive developed and owned by Nasir Montalvo (“Licensee”). The goal of *{B/qKC}* (the “Archive”) is to educate audiences on the contributions of Black LGBTQIA2S+ community members-in turn, liberating their histories from racism and homophobia-fueled erasure. The Archive and its content will used only for educational and charitable purposes, which could include worldwide distribution in any format and use in educational materials, documentary video or films, print and digital publications, museum exhibits, and promotion or fundraising materials with partner organizations (collectively, the “Purposes”).

This Materials License is granted by _____ (“I”, “me”, “my”) to *{B/qKC}* and Nasir Montalvo individually for the Purposes.

1. LICENSE. In exchange for the opportunity to have certain materials in my possession considered for inclusion in the Archive, I hereby irrevocably grant to the Licensee and its licensees and assigns the worldwide, non-exclusive right, but not the obligation, to render into electronic form the materials (“Materials”) described in the Exhibit to this License, to include all or part of the Materials in the Archive, and to publish, reproduce, publicly display, publicly perform, and modify (without destroying their historical integrity or compromising them) all or part of the Materials (including the descriptions in the Exhibit) for the Purposes, in any manner and any format and mode of distribution, whether now known or hereafter created. I understand that the Licensee is relying on this License in creating the Archive and that no monetary compensation is due in exchange for the rights I am granting.

2. OWNERSHIP AND TERM. I represent that the Licensor’s Ownership Statement on the Exhibit is true to the best of my knowledge. I agree this License is irrevocable and will be binding on my heirs and assigns.

3. CREDIT/ATTRIBUTION. Licensee will include credit for the Materials (“Credit”) in connection with the Archive using the name I request in the Exhibit, in a manner deemed appropriate by Licensee in its reasonable judgment. I agree that if Licensee decides that including Credit is impracticable in a given instance, or if it inadvertently fails to include Credit, or if it reasonably believes a different credit is appropriate, its failure to include Credit will not constitute a breach of this License.

4. REPRESENTATIONS AND RELEASE OF LIABILITY. I represent that I have the right to grant the License to Licensee and that the information in the Exhibit is accurate to the best of my knowledge. I agree never to bring any claim against the Licensee or anyone associated with the Archive (the “Released Parties”) that asserts infringement of my rights of publicity or misappropriation of name and likeness, invasion of privacy, false light, infliction of emotional distress, defamation, or any other claim arising from the use of the rights granted in this License. If I indicated on the Licensor’s Ownership Statement that I own or control the copyright in the Materials, I hereby release and hold harmless the Released Parties from any and all claims, expenses, and liability for copyright infringement or related claims arising from use of the rights granted. The Licensee will make diligent efforts to protect the Materials while they are being

digitized and to return the Materials within a reasonable time, but I hereby release the Released Parties from liability for any loss or damage to the Materials while in transit or in the custody of the Licensee.

5. NO OBLIGATION. I agree the Licensee is not required to use the Materials, I will have no right to approve the use of the Materials, I waive all moral rights in the Materials, and I will have no right to enjoin or restrain the production of the Archive or any of the Purposes. I understand the Licensee will own all rights exclusively to the Archive, and that my rights and remedies for the Licensee's breach of this License are limited to actual monetary damages only.

6. ENTIRE UNDERSTANDING. This License contains the entire understanding between the parties related to the Materials. It will be governed by the laws of the State of Missouri without regard to its choice or conflict of laws rules. Any changes to this License will be valid only if set forth in writing and signed by both parties.
